Each of the reporting persons disclaims beneficial ownership of the Shares disclosed herein except to the extent of such person's pecuniary interest therein, if any.

Remarks:

On November 6, 2013, James D. Carey, a senior principal of Stone Point Capital LLC, was appointed to the Board of Directors of Enstar. Mr. Carey is a member of the investment committee and owner of one of the four general partners of both of Trident Capital V, L.P. (the general partner of Trident V, L.P.) and Trident Capital V-PF (the general partner of Trident V Parallel Fund, L.P.). Mr. Carey is a shareholder and director of Stone Point GP Ltd., which is the general partner of Trident V Professionals Fund, L.P. On the basis of the relationships between Mr. Carey and the reporting persons, the reporting persons may be deemed directors by deputization in respect of Enstar.
