**Enstar Group Limited Reports Year-End Results**

Hamilton, Bermuda – March 1, 2013 – Enstar Group Limited (Nasdaq:ESGR) filed its annual report on Form 10-K with the SEC earlier today, reporting its earnings and financial position for the year ended December 31, 2012.

Enstar reported consolidated net earnings of \$168.0 million (or \$10.10 per fully diluted share) for the year ended December 31, 2012 compared to \$153.7 million (or \$10.81 per fully diluted share) for the year ended December 31, 2011.

Enstar's shareholders' equity at December 31, 2012 amounted to \$1,553.8 million (or \$93.30 per fully diluted share), which was up from \$1,386.1 million (or \$82.97 per fully diluted share) at December 31, 2011.
