Explanation of Responses:

- Ordinary shares were acquired upon the certification by the Compensation Committee of the Enstar Group Limited Board of Directors of the achievement of the performance objective under performance share units ("PSUs") granted on March 30, 2021. The PSUs were scheduled to vest only if and to the extent that certain performance objectives (3-year growth in fully diluted book value per share ("BVPS") and 3-year average annual operating return on equity ("ROE")) met or exceeded specified targets. The performance objectives relating to ROE were achieved above threshold and below target. The performance objectives relating to BVPS did not meet threshold, and no PSUs vested in respect of that portion of the award.
- Includes 418 Restricted Share Units ("RSUs") that vest in two equal annual installments beginning on March 20, 2024; 943 RSUs that vest in three approximately equal annual installments beginning on March 20, 2024; 167 RSUs that vest on March 30, 2024; and 15,929 RSUs that vest on February 4, 2026.
